10. MONTHLY WORKSHOP

A. Presentation and Discussion: Satellite Treatment Alternative for Dougherty Valley Sewage

Authority Manager Baker reviewed the background for seeking alternative sources of supplemental water for the project including Director Coleman's suggestion of intercepting sewage from the Dougherty Valley. That alternative was technically feasible, so Dodson Engineers has been doing further research. In Closed Session, General Counsel Maddow planned to present some of the legal and institutional issues for the alternative.

Dr. Jeff Lewandowski, Dodson Engineers, provided background for the Supplemental Water Study. His slide presentation addressed the recycled water treatment approach under consideration: how the water supply would be diverted out of the Dougherty Valley, preliminary cost analysis, as well as advantages and disadvantages of the alternative.

A recycled water supply shortfall could occur as early as 2007. Approximately 0.4 mgd to 2 mgd of Dougherty Valley wastewater would be diverted to a satellite treatment plant in a proposed park in the southwestern corner of the Dougherty Valley near Reservoir R100 and Pump Station R200B. Membrane Bio-Reactors (MBRs) would be used for wastewater treatment.

Future housing near the satellite treatment plant could be a problem as it would be within 1,000 feet of the plant. However, the plant would be entirely enclosed in a suitable building designed to blend into the surroundings and include the latest in odor and noise control technology. A preliminary cost estimate for construction of the plant is \$18.8 million. Annual operating costs are expected to be \$500,000. Amortized over 30 years, total annual costs would be approximately \$1.7 million. Water costs could range

from approximately \$8,200 per acre foot initially to \$1,400 at buildout when flows have increased. Mr. Baker indicated the costs for this alternative are high because sewage treatment would be provided in addition to recycled water treatment and it is likely the facility would run only nine months out of the year.

11. MANAGER'S REPORT

- DERWA Construction Update (Attachment) Mr. Baker reported the DERWA backbone is almost complete. Reservoirs and pump station should be done in two or three weeks, and UV/MF treatment plant is expected to be ready in April. It also appears the UV/MF facility will be large enough to meet summer demands; therefore, the system may be operational this summer.

- Operations Agreement Status Mr. Baker was very impressed with the DSRSD staff on the Start-Up Team. A brainstorming meeting to discuss indemnification language resulted in eight conceptual principles of agreement that Mr. Baker reviewed with the Board. Specific language is being developed and a negotiating meeting will be scheduled as soon as possible. The Board expressed concern over the time it is taking to complete the agreement and requested the item be on the next Board meeting agenda for further discussion.
