10. MANAGER'S REPORT

<u>Capital Projects Update – Phase 2 Recycled Water Treatment Plant Expansion Project</u> Update

Authority Manager Tognolini reviewed the item for the Board. He noted the project is progressing well with regards to budget and schedule. Substantial completion is expected in April, followed by testing and final permitting, with operational readiness expected this summer. He noted that heating, ventilation, and air conditioning (HVAC) improvements will be made, via the existing construction change order, to address new heat loads and mitigate treatment limitations. The Board and staff discussed DERWA's preparedness to meet upcoming demand this summer, noting that there were 10 days last summer that saw every drop of water used for recycled water supply, and that potable water supplementation has been key at certain peak times. Mr. Tognolini stated DERWA could request customers

reduce use, explore groundwater opportunities, and switch a few customers to potable supply to meet upcoming demands. Supplemental supply opportunities are still being considered.

Supplemental Supply Update

Authority Manager Tognolini reported that staff met with Central Contra Costa Sanitary District (Central San) at a recent Board Committee meeting to discuss potential diversion of some of its wastewater to supplement DERWA's recycled water supply. Central San staff recommended that its Board not proceed with considering such a proposal, however, the Committee indicated interest in pursuing a pilot and recommended the matter be considered at the Central San Board meeting on March 1. The Board and staff then discussed DERWA representation at that meeting to show support for the proposal. DSRSD will also hold a liaison meeting with Central San March 6 to discuss this possible coordination effort.

Authority Manager Tognolini presented outgoing Chair Mellon with a DERWA journal as thanks for his service as DERWA Chair 2017.

The Board confirmed the next meeting will be held as scheduled on March 26, 2018.

DERWA Summary & Recommendation

Approve Task Order No. 16 for Fiscal Year 2018-19 for Public Information Services with ICF Jones & Stokes, Inc.

Summary:

The DERWA Public Information Program has been supporting the San Ramon Valley Recycled Water Program during construction, startup and operation phases. The DERWA Public Information Program is coordinated by the Public Affairs Committee made up of public information staff of the member agencies. The program activities include:

- Plan and Facilitate the Annual Communications Roundtable Exercise
- Update Informational Materials
- Website Maintenance

ICF Jones & Stokes, Inc., has been providing consultant services to the Public Information Program for many years. Proposed Task Order No. 16 continues the transition from nearly full reliance on consultant support for the DERWA Public Information Program to agency staff leading most of the Public Affairs activities. The work proposed for ICF International for July 2018 through June 2019 will be the planning and facilitation of the Annual Communications Roundtable Exercise, the updating of the informational materials used to facilitate smooth communications between the member agencies in both normal and emergency situations, and updating and supporting the maintenance of the San Ramon Valley Recycled Water Program website. The 2017-18 authorized Task Order amount was \$28,530. The estimated cost of the work for Task Order No. 16 is \$31,866. The higher cost reflects the increased amount of time needed to update the website as requested, on a regular basis.

Recommendation:

The Authority Manager recommends the DERWA Board of Directors approve, by Motion, Task Order No. 16 to the August 18, 2008 Professional Services Agreement with ICF Jones & Stokes for the period July 2018 through June 2019 in an amount not to exceed \$31,866.

DERWA Summary & Recommendation

Approve Resolution No. 18-1 Amendment to DERWA's Conflict of Interest Code and Rescind Resolution No. 96-1

Summary:

Pursuant to the Political Reform Act (Act), DERWA is required to review its Conflict of Interest Code (COI) every two years. The purpose of the review is to determine if revisions are required to comply with changes to State law and Fair Political Practices Commission (FPPC) regulations. DERWA first adopted Resolution No. 96-1 on January 22, 1996, which adopted a standard COI. DERWA's current COI has been in effect since 2005 without substantive revision. DERWA staff undertook the necessary review process in January 2017 and determined that changes to the COI were warranted and submitted to the FPPC a proposed COI with supporting materials on May 8, 2017. Additional changes were requested by the FPPC during the review process. Notable revisions include:

- Designated filers are now required to submit statements of economic interests via the FPPC electronic filing system (e-Disclosure)
- "Designated Employees" renamed to "Designated Positions" which contains an updated listing of filers
- Disclosure categories broadened to two defined categories for designated positions
- Investment management officials identified as Manager and Treasurer; with filing requirements clarified
- Clarification on Attorney, Manager and Treasurer position staffing
- Out of date and/or redundant information was removed

Pursuant to FPPC regulations, a "Notice of Intention to Amend the Conflict of Interest Code for Dublin San Ramon Services District/East Bay Municipal Utility District Recycled Water Authority (DERWA)" was provided to affected DERWA filers on November 7, 2017. A required 45-day written comment period was established commencing on November 8, 2017 and concluding on December 22, 2017. In accordance with the regulations, the Notice specified that a public hearing would be held concerning the proposed COI amendment only if an interested person requested such a hearing at least 15 days prior to the close of the written comment period. No interested person requested a public hearing nor were any comments received; therefore, a public hearing on this matter is not required. The FPPC's notice of approval was sent to DERWA staff February 5, 2018.

Recommendation:

The Authority Manager recommends the DERWA Board of Directors approve, by Resolution, the amended Conflict of Interest Code and Appendix as certified by the Fair Political Practices Commission on January 31, 2018, and rescind Resolution No. 96-1.

Approve and Adopt the Fiscal Year 2018-2019 Capital and Operating Expenditure Budget

Summary:

The DERWA Joint Exercise of Powers Agreement (JPA) provides that the Authority must adopt an annual fiscal year budget showing expenditures and means of financing such expenditures.

<u>Changes from Fiscal Year 2017-2018 Budget:</u> The projects in the FY 2018-2019 capital plan can be funded under the existing capital appropriation of \$105.067 million. Capital projects continuing from the FY 2017-2018 budget are Permanent Supplemental Water Supply, New/Replacement Capital <\$50K, PSR1 VFD Replacement, and the Recycled Water Treatment Plant Expansion. There are no new capital projects proposed in the FY 2018-2019 budget.

The FY 2018-2019 proposed operating budget has been increased by \$ 513,613 (12%), with increasing projected recycled water deliveries from 4,234 acre-feet to 4,917 (14%) and increased operating labor to operate the new ACTIFLO treatment process. DSRSD has submitted a budget of \$2.501 million for the operations and maintenance of the DERWA project for FY 2018-2019. Agency contributions plus estimated revenue from water sales to the City of Pleasanton will cover the \$4.669 million budget for the O&M and administrative expenses and debt service payments. The FY 2018-2019 budget for the state loan repayment is \$1.645 million.

Expenditures and Appropriations:

The capital expenditure for FY 2018-2019 is \$1.591 million. The required contribution for operations from the Member Agencies will be based on the actual water sales for FY 2017-2018, currently projected at 73.5% DSRSD and 26.5% EBMUD. The required contributions for the state loan repayment will be based on the allocation of capital facilities at the time of payment.

For DSRSD, the estimated FY 2018-2019 contribution is \$2.641 million for the operating budget and \$0.649 million for the capital budget; for EBMUD the estimated contribution is \$1.478 million for the operating budget and \$0.381 million for the capital budget; for City of Pleasanton the estimated payments for recycled water deliveries are \$0.550 million. An anticipated grant of \$2.5 million from Proposition 1 will be used to offset capital expenditures in FY19.

Table 13 shows the Capital Project expenses and cost sharing in adherence to the adopted Water Sales Agreement.

<u>Funding:</u> The Capital Program has secured \$5 million in grants, \$24.7 million in loans from Proposition 13 funding, and \$14.9 million in federal funding.

Recommendation:

The Authority Manager and Treasurer recommend the DERWA Board of Directors approve, by Resolution, the DERWA Fiscal Year 2018-2019 Budget.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE DSRSD•EBMUD RECYCLED WATER AUTHORITY APPROVING AND ADOPTING THE FISCAL YEAR 2018-2019 CAPITAL AND OPERATING EXPENDITURE BUDGET

WHEREAS, the Joint Exercise of Powers Agreement under which DSRSD•EBMUD Recycled Water Authority (DERWA) was formed provides that before the year end, the Authority's Board of Directors must adopt an annual budget for the following fiscal year showing proposed expenditures and the proposed means of financing such expenditures; and

WHEREAS, the DERWA Treasurer and the Member Agencies have reviewed and the Authority Manager has recommended, a proposed Capital and Operating Expenditure Budget for Fiscal Year 2018-2019; and presented the proposed budget at the March 26, 2018 DERWA Board Meeting; and

WHEREAS, the Board of Directors has considered all the oral and written information presented.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the DSRSD•EBMUD Recycled Water Authority, a Joint Powers Authority, located in the Counties of Alameda and Contra Costa, California, as follows:

- 1. An operating budget appropriation totaling \$4.669 million is hereby approved and adopted for FY 2018-2019 as presented in "Attachment A".
- 2. The capital budget appropriation is unchanged and remains at \$105.067 million as presented in "Attachment A". Adjustments between projects shall be subject to the same limits established by DERWA accounting and control procedures for expenditures. For the operating budget, appropriations are made by work element.
- 3. In order to provide for completion of work on projects authorized but not completed as of the close of the fiscal year, balances remaining at the close of FY 2018-2019 are hereby appropriated for expenditure in the subsequent fiscal year, in addition to the applicable fiscal year appropriations for capital and operating expenditures.
- 4. The Source of Funds for the capital and operating expenditures for FY 2018-2019 shall be from Member Agency contributions, payments made by City of Pleasanton in accordance with the January 7, 2014 Agreement to Provide Recycled Water Services by and between DERWA and the City of Pleasanton, state and federal grants or loans,

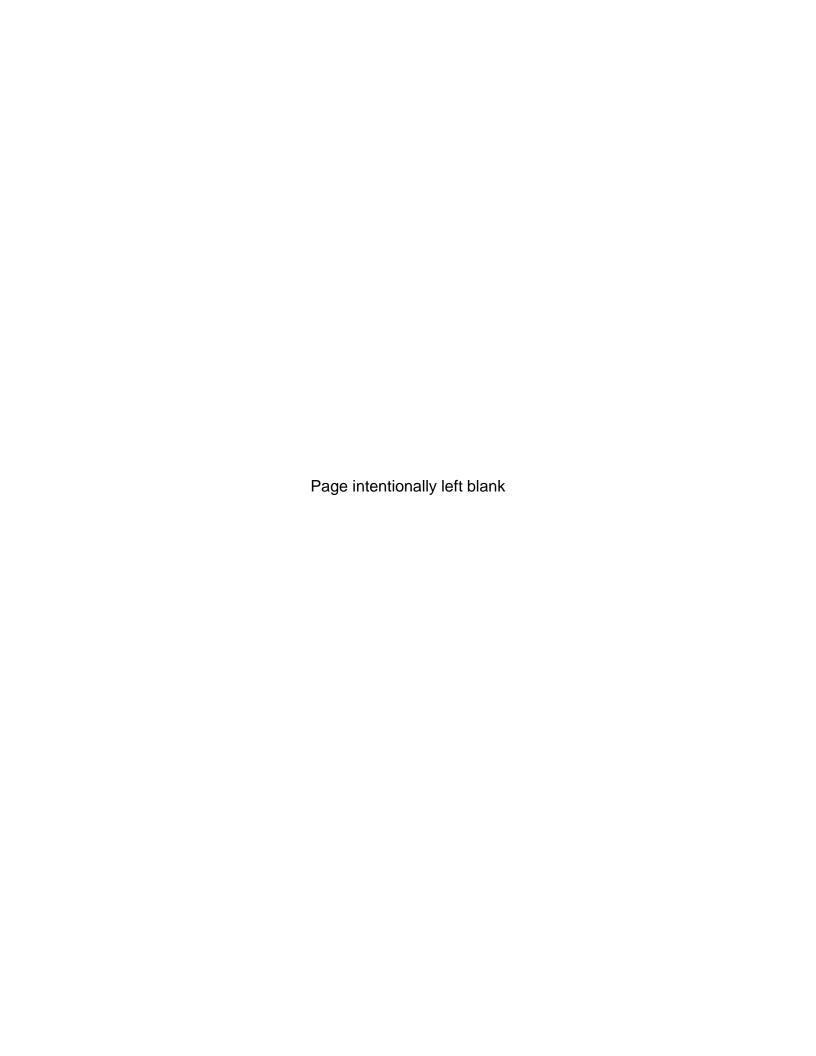

and/or borrowed sources such as but not limited to commercial paper as prudently determined by the DERWA Treasurer.

- After consideration of DERWA reserves and working fund balances as required under Article 13 of the Joint Powers Agreement and given the Source of Funds as described in paragraph 4 above, the capital and operating expenditure budget projects a revenue shortfall.
- 6. In accordance with Article 18 of the Joint Powers Agreement, a series of demands shall be made of the Member Agencies for funds equal to the revenue shortfall as determined by the percentages in the Water Sales Agreement.
- 7. All expenditures shall be authorized and revenue shall be collected in accordance with DERWA's adopted Accounting Control Procedures.
- 8. The Treasurer shall analyze cash flow needs and invoice Member Agencies as needed to maintain prudent and sufficient working capital balance for DERWA.
- EBMUD and DSRSD shall share in the expense for the operations and maintenance of the DERWA facilities based on their proportion of actual water deliveries.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE DSRSD•EBMUD RECYCLED WATER AUTHORITY APPROVING AND ADOPTING THE FISCAL YEAR 2018-2019 CAPITAL AND OPERATING EXPENDITURE BUDGET

WHEREAS, the Joint Exercise of Powers Agreement under which DSRSD•EBMUD Recycled Water Authority (DERWA) was formed provides that before the year end, the Authority's Board of Directors must adopt an annual budget for the following fiscal year showing proposed expenditures and the proposed means of financing such expenditures; and

WHEREAS, the DERWA Treasurer and the Member Agencies have reviewed and the Authority Manager has recommended, a proposed Capital and Operating Expenditure Budget for Fiscal Year 2018-2019; and presented the proposed budget at the March 26, 2018 DERWA Board Meeting; and

WHEREAS, the Board of Directors has considered all the oral and written information presented.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the DSRSD•EBMUD Recycled Water Authority, a Joint Powers Authority, located in the Counties of Alameda and Contra Costa, California, as follows:

- 1. An operating budget appropriation totaling \$4.669 million is hereby approved and adopted for FY 2018-2019 as presented in "Attachment A".
- 2. The capital budget appropriation is unchanged and remains at \$105.067 million as presented in "Attachment A". Adjustments between projects shall be subject to the same limits established by DERWA accounting and control procedures for expenditures. For the operating budget, appropriations are made by work element.
- 3. In order to provide for completion of work on projects authorized but not completed as of the close of the fiscal year, balances remaining at the close of FY 2018-2019 are hereby appropriated for expenditure in the subsequent fiscal year, in addition to the applicable fiscal year appropriations for capital and operating expenditures.
- 4. The Source of Funds for the capital and operating expenditures for FY 2018-2019 shall be from Member Agency contributions, payments made by City of Pleasanton in accordance with the January 7, 2014 Agreement to Provide Recycled Water Services by and between DERWA and the City of Pleasanton, state and federal grants or loans,

and/or borrowed sources such as but not limited to commercial paper as prudently

determined by the DERWA Treasurer.

5. After consideration of DERWA reserves and working fund balances as required under

Article 13 of the Joint Powers Agreement and given the Source of Funds as described in

paragraph 4 above, the capital and operating expenditure budget projects a revenue

shortfall.

6. In accordance with Article 18 of the Joint Powers Agreement, a series of demands shall

be made of the Member Agencies for funds equal to the revenue shortfall as determined

by the percentages in the Water Sales Agreement.

7. All expenditures shall be authorized and revenue shall be collected in accordance with

DERWA's adopted Accounting Control Procedures.

8. The Treasurer shall analyze cash flow needs and invoice Member Agencies as needed

to maintain prudent and sufficient working capital balance for DERWA.

9. EBMUD and DSRSD shall share in the expense for the operations and maintenance of

the DERWA facilities based on their proportion of actual water deliveries.

10. All expenditures in FY 2018-2019, except those listed in the operating budget, are

DERWA Summary & Recommendation

Approve and Adopt the Fiscal Year 2018-2019 Capital and Operating Expenditure Budget

Summary:

The DERWA Joint Exercise of Powers Agreement (JPA) provides that the Authority must adopt an annual fiscal year budget showing expenditures and means of financing such expenditures.

<u>Changes from Fiscal Year 2017-2018 Budget:</u> The projects in the FY 2018-2019 capital plan can be funded under the existing capital appropriation of \$105.067 million. Capital projects continuing from the FY 2017-2018 budget are Permanent Supplemental Water Supply, New/Replacement Capital <\$50K, PSR1 VFD Replacement, and the Recycled Water Treatment Plant Expansion. There are no new capital projects proposed in the FY 2018-2019 budget.

The FY 2018-2019 proposed operating budget has been increased by \$ 513,613 (12%), with increasing projected recycled water deliveries from 4,234 acre-feet to 4,917 (14%) and increased operating labor to operate the new ACTIFLO treatment process. DSRSD has submitted a budget of \$2.501 million for the operations and maintenance of the DERWA project for FY 2018-2019. Agency contributions plus estimated revenue from water sales to the City of Pleasanton will cover the \$4.669 million budget for the O&M and administrative expenses and debt service payments. The FY 2018-2019 budget for the state loan repayment is \$1.645 million.

Expenditures and Appropriations:

The capital expenditure for FY 2018-2019 is \$1.591 million. The required contribution for operations from the Member Agencies will be based on the actual water sales for FY 2017-2018, currently projected at 73.5% DSRSD and 26.5% EBMUD. The required contributions for the state loan repayment will be based on the allocation of capital facilities at the time of payment.

For DSRSD, the estimated FY 2018-2019 contribution is \$2.641 million for the operating budget and \$0.649 million for the capital budget; for EBMUD the estimated contribution is \$1.478 million for the operating budget and \$0.381 million for the capital budget; for City of Pleasanton the estimated payments for recycled water deliveries are \$0.550 million. An anticipated grant of \$2.5 million from Proposition 1 will be used to offset capital expenditures in FY19.

Table 13 shows the Capital Project expenses and cost sharing in adherence to the adopted Water Sales Agreement.

<u>Funding:</u> The Capital Program has secured \$5 million in grants, \$24.7 million in loans from Proposition 13 funding, and \$14.9 million in federal funding.

Recommendation:

The Authority Manager and Treasurer recommend the DERWA Board of Directors approve, by Resolution, the DERWA Fiscal Year 2018-2019 Budget.

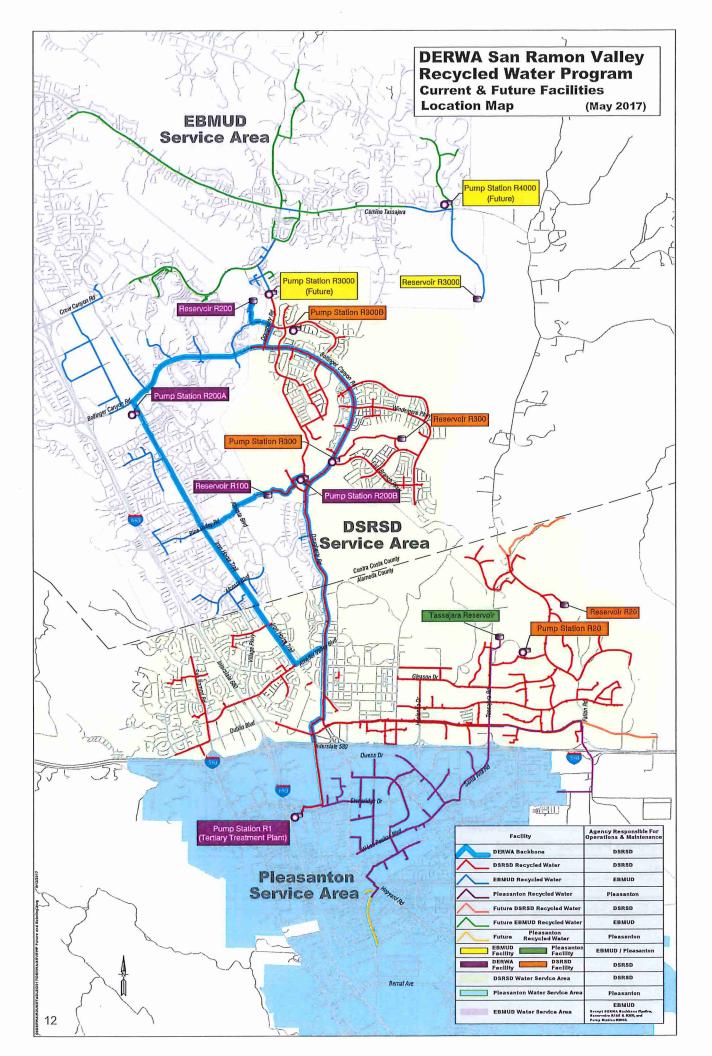

Project: Supplemental Water Supply

Description: This project will provide Supplemental Water for DERWA that is needed to avoid peak month supply shortfalls that will occur within the next few years.

Alternative sources of supply currently under consideration are additional supply of treated wastewater effluent from Livermore and/or raw wastewater from Contra Costa County Sanitary District (CCCSD), and local groundwater. Preliminary engineering studies of the alternatives were completed in 2005. The January 17, 2014 DERWA/Pleasanton Recycled Water Services agreement allows DERWA to utilize Pleasanton wastewater that is not used by the Pleasanton recycled water program. Current 5-year recycled water demand projections by the participating agencies show the peak month demand will exceed the wastewater flows from DSRSD and Pleasanton. In FY 2019, the DERWA will work toward completion of the CCCSD diversion and perform detailed studies of opportunities to use groundwater to meet peak demands.

Project: Recycled Water Treatment Plant Expansion

Description: This project will expand the recycled water sand filtration and ultraviolet (UV) disinfection facility to meet the DSRSD, EBMUD and Pleasanton's water demand projections through 2019-2020. The projections show the peak day demand will exceed the RWTP capacity (including the capacity of the 6th Sand Filter addition) by 2017. The Microfiltration/Ultraviolet Disinfection Plant can provide the needed peak capacity for in the interim if needed. This project will expand the facility capacity from 11.6 to 16.2 mgd. The expansion includes the construction of high-rate ballasted flocculation basins upstream of the existing tertiary filters improving the quality of the filter feed allowing them to operate at a higher loading rate. It also includes the addition of twenty UV disinfection modules, two tertiary influent pumps, two high lift product water pumps and associated electrical and mechanical equipment. Construction is expected to be complete in 2018 with testing and filer rating continuing into 2019. \$2.5 million in grant funding from the state is anticipated to offset capital costs.

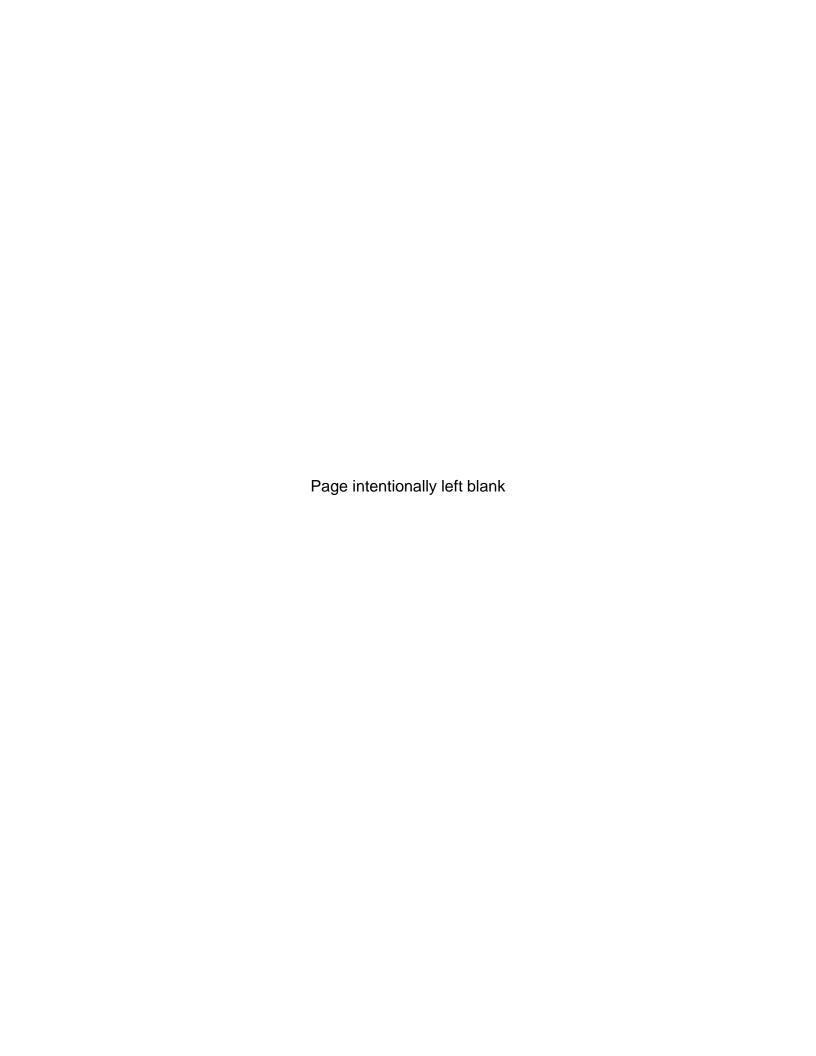
