#### 11. MONTHLY WORKSHOP

A. Presentation and Discussion: Public Information Quarterly Report

DERWA Community Affairs Representative Ingrid Norgaard reported project outreach goals for October to December 2004 necessitated distributing a variety of public notices regarding pipeline installation and tank site work. Other efforts included coordinating the October 2004 State Water Resources Control Board Check Presentation Ceremony, and submitting applications for two awards for the Public Education Community Outreach Program—one for the WateReuse California Section and another for the California Water Environment Association. The Web site and community hot line also were regularly updated and maintained.

Boardmembers viewed a map showing pipeline installation completed to date, and two sections of pipeline that remain to be completed—Pipeline DL near Tank 2 and the U.S. Army Corps of Engineers' portion of the project.

Recent project issues included problems with construction dust and hydroseeding hay near Tank 1, early construction start times on Bollinger Canyon Road, and trucks leaving dirt on streets near Tank 2. During 2004 eleven individuals called regarding pipeline installation issues along Amador Valley Boulevard, Pine Valley Road, Bollinger Canyon Road and the Iron Horse Trail, and six individuals called about tank construction issues.

DERWA Web site hits numbered 5,022 in October, 5,149 in November, and 4,281 in December. The most requested pages in 2004 were the Home Page, Construction Schedule Map and Construction Updates.

In the future, notices will be sent out covering tank construction. The project Web site will be updated and transitioned to emphasize operations. Member Agencies also would like a secured area set up on the Web site so they can share customer information, complaints, reports, guidelines and more. Additional awards will be pursued and briefings will be held as needed.

A new task implementing a cross-connection prevention outreach plan has been added to Jones & Stokes' current Scope of Work and budget. The number one public safety concern with recycled water comes from cross-connections. The outreach will be targeted and include a brochure describing DERWA's service area and types of customers served, who to contact if purple pipes are located in a contractor's work area, and other information to distribute at permit counters in Dublin, and San Ramon, as well as in Alameda and Contra Costa counties.

Future efforts will include assisting Member Agencies with customer coordination activities since at least three customers will be served by both DSRSD and EBMUD. Although Member Agency customer guidelines will never be identical, they need to be as consistent as possible in order to make using recycled water easy for customers. Other future efforts will include coordinating the Grand Opening media event and addressing community concerns as needed.

Chair Scannell encouraged DERWA representatives to do a presentation at CASA on this outreach education project.

#### 12. MANAGER'S REPORT

• <u>DERWA</u> Construction Update (Attachment) – DSRSD believes the Tertiary Treatment Plant will be ready for performance testing by the contractor in July

2005. If the facility passes the test, the Department of Health Services will need to review the test results and send a letter of approval before moving forward. As a result, the Tertiary Treatment Plant may not be available until September or October 2005.

- Contracts Initiated Since the Board Meeting of November 22, 2004 (Attachment)
- Operations Agreement Status DSRSD and EBMUD have reviewed the draft Operations Agreement. Indemnity provisions are still under discussion. EBMUD has asked for blanket indemnification by DSRSD for operation of the facility. DERWA's insurance broker believes an operator, including a public operator, usually indemnifies the owner. Mr. Baker's current concern is timing since DSRSD plans to start up and operate the facility in April 2005.

Director Hansen indicated the DSRSD Water Committee had discussed this issue and did not agree with that interpretation of the agreement language. Mr. Baker believes a summit meeting might be needed in order to reach agreement in February, with Board approval in March, prior to facility start up.

- <u>Dougherty Valley Satellite Treatment Alternative</u> Director Coleman requested additional work on the satellite treatment option. Following review, Mr. Baker suggested putting a satellite treatment plant next to Pump Station R200B to intercept sewage from the Dougherty Valley. Dodson Engineers is evaluating this new alternative to the level of the other Permanent Supplemental Water alternatives.
- Confirm Next Meeting Date –The next DERWA Board meeting is scheduled for February 28. The meeting will start at 6:30 p.m. DSRSD named its 2005 DERWA Board appointments as Directors Scannell and Hansen. DSRSD Boardmember Richard Halket was named the Alternate Director. EBMUD appointments to DERWA should be announced soon.

#### 13. BOARDMEMBER ITEMS

As a result of DSRSD Director Tom McCormick's retirement, Director Hansen asked that at the next meeting the DERWA Board present an acknowledgement of appreciation for his service.

V.C. Mellon suggested DERWA send out an electronic version of the next DERWA Board packet.
